Pack Life Canine Rescue (hereafter PLCR) will provide the Adopter with an adult dog that has been tested for heartworm disease, received rabies and routine vaccinations as recommended by a licensed veterinarian, de-wormed, treated for fleas and ticks, given heartworm preventative, spayed/neutered and microchipped. Documentation of vet services and vaccinations will be provided to the Adopter upon receipt of the completed contract and adoption fee. The Adopter will be informed of any know history of medical or behavioral issues. PLCR agrees to refund the adoption fee if the adopted animal is returned within 14 days of the adoption date. PLCR makes no warranty as to the physical condition or temperament of this dog; this dog is adopted as is.

#### Adopter Agreements & Responsibilities

1. If this dog does not adapt to my home or I cannot keep the dog for any reason, I will contact Pack Life Canine Rescue to offer the animal back to the organization before relinquishing custody or possession of this dog to anyone else and/or prior to euthanizing this dog for a behavioral or medical issue. \_\_\_\_\_
2. I agree to assume full responsibility for the veterinary care for this dog, including an annual examination and routine/recommended vaccinations and tests. I will keep this dog free of parasites, including fleas and ticks, and agree to provide monthly heartworm prevention medication for the life of this dog. \_\_\_\_\_
3. I will provide this dog with a fully fenced-in yard, unless otherwise approved by PLCR. This dog will be kept on a leash at all times when outside of a securely fenced-in area. This dog will never be kept chained or tethered without direct supervision (a caretaker in the same immediate space with the dog) and then only for less than 1 hour at a time. This dog will live primarily in the main living quarters of the owner, with the owner and other members of the household. \_\_\_\_\_
4. I will provide a flat buckle/snap collar for the dog to wear at all times (not a slip/choke/prong collar) and the collar must have a rabies tag and identification tag (with dog's name and owner's contact information) affixed to the collar at all times. I will keep this dog's microchip information updated at all times and will notify the microchip company of any change of contact information immediately. \_\_\_\_\_
5. I will not abuse, neglect or physically punish this dog at any time. If this dog exhibits behaviors that are problematic, I will consult with PLCR, a veterinarian or dog trainer to help deal with the problem behaviors. \_\_\_\_\_
6. I acknowledge and agree that PLCR has the right to remove this dog at any time for my failure to comply with the terms of this agreement, or for any misrepresentations with respect to the adoption application or this agreement by me. \_\_\_\_\_
7. I agree that this is a legally binding contract and by my signature agree to all terms herein. \_\_\_\_\_
8. I confirm that all information given in this contract is true, correct and accurate, and that following my possession of the subject dog, I am solely responsible for any actions of this dog and will indemnify and hold harmless PLCR and its representative from any liabilities, injuries or losses caused by this animal or any actions, claims, suits or demands that may arise from such injury, damage or loss. In the event that I breach the terms of this contract, I agree to pay to PLCR all costs of recovering and treating the dog, including but not limited to: veterinary evaluations and treatment, court costs and attorneys' fees. I further agree to return the dog upon the demand of PLCR.
